### **The 2023 Annual General Meeting of The Club**

**held at Meon Hall, Meonstoke**  
**On THURSDAY 2<sup>ND</sup> March 2023 at 7.00pm**

**Present:** Mr Chris Martin, (President) in the Chair, Mr Alastair Wilson (Chairman of Council), Mrs Sarah Cowrick (Secretary) and 80 Club Members and guests.

The President opened the proceedings welcoming members. He also welcomed our guest speaker, Alastair Stewart. The President wished to record his thanks to Barclays Commercial Bank for their sponsorship of the event.

1. **Apologies** were received from Luke Axel-Berg, Jamie Balfour, Tim Butler, Mark Charter, Peter Corbett, Henry McCowen
2. **Minutes of the 2021 Annual General Meeting held on 2<sup>nd</sup> March 2022** having been previously circulated, were confirmed by those at the meeting. Proposed by Mr Frank Moffat and seconded by Mr David Rees and signed as a true record and signed by the President.
3. **Report and Accounts for 2022:**

The results of the competition are a closely guarded secret until the Friday following the judging, when we come together for our annual farm walk, which was kindly hosted by James & Claire Hewetson-Brown at Ashe Warren Farm, Overton. James was the Championship winner in 2022 and it was incredibly special to glimpse an insight into his wildflower seed and turf production. Understandably, it was a sell-out event with members delighting in what they saw.

Alison Coleman kindly hosted a Ladies' visit at the end of June on what was a lovely summer day at her Lower Norton Flower Farm. Members were treated to a flower arranging demonstration, a guided tour around the flower field and the chance to arrange and take home their own posy of flowers.

The visit was rounded off with delicious tea and cake on the lawn!

With no study tour in 2022, Sarah Cowlrick kindly arranged an autumn lecture at the Farmers Club in London with Lord Deben, John Gummer as our guest speaker. 35 members made the journey and were not disappointed, which was generously supported by Victoria Read and her team at Lloyds. As chairman of the UK's independent Committee on Climate Change, Lord Deben did not pull any punches and was keen to hold the Government and opposition to account in their lack of cohesive policies and action plan. We are fortunate to have an upper house, where former government ministers are not afraid to toe the party line. After the lecture we were treated to a delicious dinner at the Club before catching the last train home.

## Report on the Hampshire Farms & Conservation Competition 2023



The Committee took the opportunity to stage a full and detailed survey of past competitors on the future format of the Competition which gave a unique opportunity for competitors to give their feedback. The results of the survey which were presented to the Committee, the

Hampshire Farmer's Club Council and the Trustees was an overwhelming mandate of support to continue. This created a positive vibe which in turn led to one of the most successful Competitions to date and provides confidence for future Competitions.

There were 29 entrants 5 of whom were new or returning entrants. The total area judged amounted to 28,000 hectares and included many younger generation farmers and a wide range of enterprises and innovative diversifications.

Judging days in June were blessed with good weather and the 10 judges who came from Lincolnshire, Cornwall, Oxfordshire, Warwickshire and West Sussex enjoyed the usual exceptional hospitality at Bereleigh House, East Meon and spent many hours deliberating over all aspects of the farms they had seen. The Competition Committee work hard all year to select suitable judges and sponsors without whom the competition would not be able to be run.

My thanks to our joint main sponsors NatWest and AGR11 and to our Class Sponsors, Apecs, Robin Appel Ltd, Bright Seeds, Hunt Forest Group, Infinity Energy, Martin and Company, NFU Mutual, Syngenta, Thrings Solicitors and SOYL.

The judges were escorted round the Hampshire





countryside by very able, young Stewards working in the industry. On the Monday night, competitors, judges, committee members, stewards and sponsors enjoyed a BBQ supper provided by local farmer, Matt Atkinson and his team at West Stoke Farm, by kind permission of The Rowsell family. Robin Appel kindly supplied the beer.

The results were announced at the Hampshire Farmers' Club annual farm walk at Ashe Warren Farm, Overton which was attended by 240 members by kind invitation of the Hewetson-Brown family.

Alastair Wilson, acting Chair commented "After a late start in planning the event it was extremely rewarding to see it come together so well and for some of the new entrants to be awarded for their efforts. My thanks to the committee for stepping up and to our sponsors, without whom it could not be staged at all."

I feel honoured to be elected as Chair of the Competitions and I look forward to working with my Vice Chair, Sam Burge to make the 2024 Competition another successful event. The Competition needs to evolve to reflect the dramatically changing landscape of the Agricultural Industry and to encourage the ethos of sharing information as well as Championing the high level of farming expertise in Hampshire.

## Technical Evening 2023 Report

Unusually, this year's Technical Evening took place outside the county in Bedfordshire, and more particularly at the School of Water, Energy and Environment at Cranfield University, for a rather more academic look at soils, regenerative farming and remote sensing.

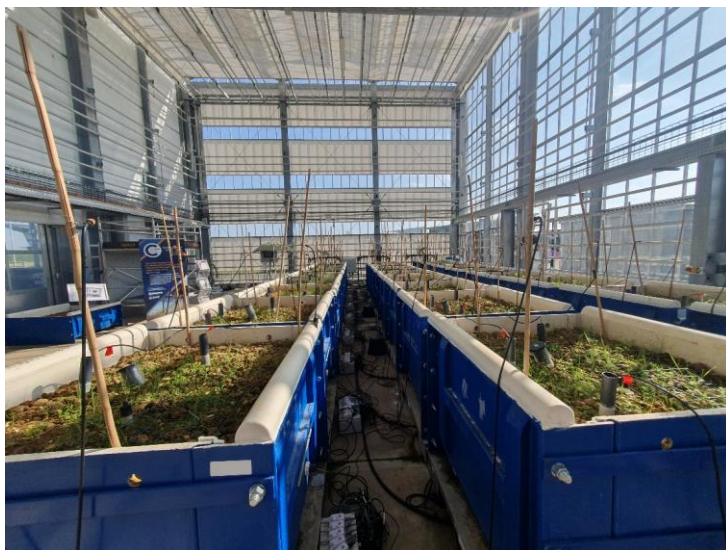
Able to be hosted by Dr Toby Waine (Senior Lecturer in Applied Remote Sensing), the Club was treated to a tour of the superb facilities at Cranfield University for what was an extremely interesting and thought-provoking evening looking ahead to the future of

agriculture and associated technologies.

Dr Waine's research can be grouped into two main themes:

Land Resources monitoring for crop inventory – where remote sensing technology is integrated with existing data sets to provide local, regional and national inventories of crops and vegetation.

Food security, through the application of remote sensing to precision agriculture – where the focus is the remote sensing of





crops for canopy management and yield prediction. This focusses on developing models and techniques to exploit fully the underlying variation of nutrients, water and soil so that fields are managed in a way that reflects their viability (e.g. in soil properties) over space and time.

During the visit Dr Waine and his team showed members around the campus' facilities including the University's glass houses and laboratories. This prompted discussions concerning soils; environmental protection topics such as soil erosion including seeing an indoor rainfall erosion experiment facility; cover crops and their benefits; looking at various issues where there are

long term row crops in the ground such as asparagus; discussing soil organic matter; and considering the latest GPS technologies etc. A particular highlight of the evening was a visit to the University's famous Soil Archives which includes soil samples from all over the world and which has been collated over many years to produce one of the most, if not the most, significant and specialist archives in the country and worldwide.

We also looked at the world's first glasshouse designed to study plant-soil-water systems at field scale under a multi-sensor phenotyping gantry. This facility offers an ideal environment to test and use sensor-based evaluation of soil and crop systems and to demonstrate the complete cropping cycle from tillage operations, through drilling, plant establishment, crop development to harvest and post-harvest. The facility is open to research organisations, agribusinesses, farmers and agronomists to explore how soil management can impact soil and crop health and protection. One of the studies being undertaken at the time of our visit was into the successful restoration of chalk grassland after disturbance (e.g. for a pipeline) and investigating how different depths of soil and subsoils and pH levels etc could impact on the growth, diversity and overall success of the grass re-establishment.

Dr Waine and his colleagues within the soil management laboratories also confirmed that they are keen to work with any farmers or groups of farmers who are interested in a particular area of research and/or who have a

particular commercial project they would like to investigate. They also have students who may be able to undertake a Master's degree on the back of projects such as this and who would be keen to be involved.

The tour ended with light refreshments and further conversation with Dr Waive and his colleagues who provided expert responses to various questions posed by members and also sent us all away with

interesting scenarios to ponder ourselves!

All in all a very technical and thought-provoking evening and well worth the journey!

## Next Generation Report 2023

Following the success of the first HFC Next Gen event in 2021, it was great to be holding another event for the younger HFC generation and potential new members of the club – this time free from Covid restrictions!

We were blessed once again with a sunny evening for a farm walk around Vale Farm, kindly hosted by the Burge family. With a full attendance of over 50 people we just about managed to squeeze everyone on the trailer, stopping first at the organic vineyard run by Sam's cousin Ben Adams. Ben gave a fascinating talk about the world of wine, fielding a number of questions about the complexities of organic production, different grape varieties and the marketing of his premium still wines.



Next stop was with Sam, for a run down on the arable side of the business which includes a range of combinable crops alongside the production of sage for the essential oils market.

After this we moved on to the poultry unit, which is a new venture housing 32,000 free range laying hens. Here Sam and poultry manager Richard gave an overview of how the chickens fit alongside the rest of the business, explaining the volatile first couple of years which has ranged from sky-high feed and energy prices, bird flu in the UK and now an egg shortage! Also of interest was the growth of Vale Farms own brand of free range eggs, delivered into local restaurants, cafes and sold



from the farm in order to add value.

The final two stops gave an insight into the diversification at Vale Farm, firstly with the 'Pigsty at Pitt' which is a luxury glamping pod run by Sam's wife Min. Installed during Covid, the Pigsty won AirBnB's most Wish-Listed Property in 2021, and is a great example of how a relatively small diversification can become a major success thanks to its niche design, amazing location and clever marketing!

Finally we stopped off at Sam's well renowned Hall & Burge self-storage, which has grown from a couple of containers to hundreds, ranging from indoor lock-ups to

outside shipping containers of all shapes and sizes. These house most of Winchester's clutter, and are another great example of how farm diversifications can grow into substantial businesses!

Once back at the farmyard we enjoyed a delicious BBQ prepared by Min Burge & Angie Trenchard, rounding off a hugely inspiring and informative evening which was thoroughly enjoyed by everyone who attended.

They are growing a combination of annuals, biennials, perennials, herbs, shrubs and bulbs on a one acre site. They grow all the English country favourites; Sweetpeas, Roses, Clematis, Cornflowers, Larkspur, Sweet Williams, Cosmos, Ammi Majus, China Asters, Phlox to name but a few. All are selected for their scent, colour, movement, form, vase life and sheer beauty, the flowers are the English country garden at their best. The flower field when in full bloom is a sight to behold and has become a wonderful habitat for insects and birdlife too.

The flowers they grow lend themselves beautifully to wedding and event flowers. They supply flowers to event florists and to customers wanting to create their own wedding flowers (DIY weddings). They deliver bouquets and subscription bouquets locally. They also hold workshops

## Hampshire Farmers' Club

### The Treasurer's Financial Report For 2023

I am pleased to be able to report to the Members that the Club's finances, as set out in the balance sheet disclosed in this annual report, remain healthy. The structure of the balance sheet does look somewhat different to last year given the transfer of funds from the Hampshire Farms Competition Committee (HFCC) as this is currently being run through the Club. This has meant an increase in funds at bank with a corresponding increase in creditors for funds held for HFCC.

The Club made a surplus this year of £233 compared to £320 in 2022. With a full schedule of events, including the Young Farmers event, the Club produced a small overall surplus after costs. The ability for the Club to run all of these is underwritten by the generosity of the hosts and sponsors who allow charges to be kept at manageable levels.

I would like to thank members for their continued support of the Club during the last year. Subscriptions were up slightly on last year. This has given us the ability to fund the Club administration costs without calling on our reserves.

It is always the intention that the Club should keep in equilibrium with the level of subscriptions matching the normal running costs. Council review these on an annual basis and are currently content that the rates are appropriate with regard to the annual costs for the Club.

The accounts shown in this report are a consolidation of the accounts for each individual event that were presented to Council for their approval.
